Tuition is based on 10 or 11 equal payments.

Cash, Money Order, Visa, MasterCard, Discover, American Express or checks payable to: *St. Pius V Catholic School* will be accepted as payment towards your account.

All December and May transactions must be in cash, money order or credit card ONLY.

Payment of full year's tuition received before September 1st will be granted a 5% discount.
Receive 2% discount for tuition paid in two installments: August 1, 2009 and January 1, 2010.

ADDITIONAL FEES

INSTRUCTIONAL SUPPLY FEE: (non refundable): \$350/**per child**; \$400 after July 15th, 2009. Pays for consumable books, yearbook, materials, testing, technology, diocesan tax, student insurance, H.S.A. and TCCED fee.

SERVICE HOURS: All families are expected to work at least 15 service hours. If service hours are not completed by May 1st there will be a \$15.00/per hour charge for hours not completed.

TUITION LATE FEE: \$45.00 for payments received after the 7th of the month.

RETURNED CHECK FEE: \$40.00 per returned check.

SPORTS FEE: \$100 first sport, \$55 each additional sport – *Mandatory for participation and nonrefundable.*

The tuition you pay does not cover the total cost of educating your child. The actual cost of educating each child is \$5,289.00. We thank the parishioners of St. Pius V Catholic Church for investing in our school. We ask that you support us in all our fund raising efforts and other school activities. Tuition assistance is available to eligible families. If you are currently receiving Financial Aid you must reapply every year. Annual Income Eligibility Parent Survey form required at the time of registration.
